

SOUTH PETHERWIN PARISH COUNCIL: PARISH COUNCIL MEETING

Minutes of the meeting of South Petherwin Parish Council held on 8th June 2016 in the Village Hall at 7.30pm.

Present: Councillors J Butler (Chairman), C Powlesland, J Whiting, A Hosking, D Rogers, P Parsons.

Representations from the public:

Mrs Vernon, informed the Council about the Church Clock Fund to date. Of the £18,000 required, they have raised £3522 & have £2500 promised. She asked if the Parish Council could fund the tea, sugar, milk etc for the Queen's 90th birthday celebration tea and also if any left over money from the tea could be donated to the Fund. She also asked if the Parish Council would be able to give any other donation.

Cllr Parsons, sitting with the public, advised that the West Petherwin proposed development was at the pre-app stage.

A query regarding the aforementioned pre-app was put to Cllr Parsons by a parishioner ie if there had been a change to the pre-app since the consultation. Cllr Parsons confirmed that there had not. The Council explained that the pre-app stage is for information only, and that the Council do not put any comments forward until a full application stage.

16/069 Highways & Footpaths Matters

- 1. Speed of cars on B3254:** speed monitoring data forwarded, but need summary and next steps. Cllr Parsons to meet with Oliver Jones of Cornwall Council Highways.

- 4. Discontinuation of paper planning applications.** Procedure statement is on parish website. Equipment being purchased. It was agreed to add on an extension lead, extra printer cartridges & A3 paper. It was also agreed that Cllr Rogers should advise the costs that she has incurred for printing out A3 plans for the meetings for the past few months.
- 5. Toilets.** Door is fixed & a shutter will be put on it. Paper towel holder to be put on wall.
- 6. Queen's 90th birthday June celebrations.** Tea & trail on Sunday 12th June. The Council were to fund the refreshments. Any excess money to be put towards the Church Clock Fund.
- 7. Risk Assessment.** To be reviewed.
- 8. Code of Conduct training.** Cllr Rogers attended the training in Saltash and found it very informative. It would be helpful if Cornwall Council could organised more local training sessions.
