Parish Council Meeting

A meeting of South Petherwin Parish Council was held in the Methodist Chapel Hall on Wednesday 14th January 2015.

Representations from the public. Mr Parsons provided information about the creation of the South Petherwin Emergency Defibrillator group (SPED) established to fund the purchase of a defibrillator for the parish, provide training, monitoring and on-going management. Mr Parsons also commented on the need for members of the public to keep dogs under control when using public footpaths and crossing farmland particularly when stock is present.

15/001 Nomination and Co-option of Councillors. Mr Nik Burgess, Mrs Julie Butler and Mrs Chris Powlesland having been present and introduced to Council at the last meeting were nominated for co-optio

n by Cllr Parsons, seconded by Cllr Mrs Rogers. Proposal was carried unanimously and Councillors were welcomed to the Parish Council by the Chairman.

15/007 Police Matters

No issues had been reported by the police. A replacement PCSO has yet to be appointed.

15/008 Highways and Footpaths..

1. Trekelland Bridge – an email had been received from Cornwall Council confirming the content of the meeting of 5th November and ongoing consultations.
2. Temporary closure of Slipper Hill (2nd – 6th February) notified to Council. At suggestion of Cllr Screech Clerk has written suggesting work to Trekelland Bridge is undertaken concurrently.

15/009 Current and on-going business .

1. Precept Budget 2015/16. Clerk presented a report and proposal to council. After considerable discussion including reference to the need for building reserves a proposal to increase the precept from £5000 to £6000 was made by Cllr Rogers seconded by Cllr Screech. Proposal Carried.
2. Noticeboards. Assessment of work required still ongoing.
3. Amendments to Standing Orders. Cllrs Parsons and Rogers are making progress with review.
4. The Emergency Box from Western Power is being passed around groups in the village and will be returned to the Clerk so the council may decide on its final location.

15/010 New Business

1. Proposal - to approve the siting of the public access defibrillator on the front of the public conveniences and meet the cost of electricity supply (approx. £20pa) After discussion the matter was proposed by Cllr Screech, seconded by Cllr Burgess. Proposal carried.
