19/126 Highways & Footpaths Matters

Actual as at 1st December 2019

- a. Trelinnoe Gardens/Close footpath adoption. A letter had been sent to the landowner, nothing heard as yet.
- b. Pennygillam culvert and fence. After a survey of the fence Cornwall Council had confirmed that the entirety of the fence required replacing, this work would be carried out in 2020. A survey of the culvert was also scheduled for 2020.
- c. Trethevy speed bump. Ongoing.
- d. Dog bins. BIFA were not able to provide a quote until the contract renewal was agreed in mid 2020.
- e. Community Network Highways Fund. Cllrs met with a Cormac representative on 11th December. It was proposed by Cllr P Parsons, seconded by Cllr D Rogers, that the suggestion by Cormac, that a online consultation to capture fully all parishioners views on the proposed yellow lines, be taken up. All were in favour.
- f. Church tower floodlights. Ongoing.
- g. Speeding traffic. Ongoing, waiting to hear from St Thomas parish council regarding their investigations into the use of a self purchased Speed Limiter device. This issue would also be discussed at the next parish event.
- h. Moss on Tiny Meadows path. Cormac have advised that the path would be cleared.
- i. Pavement clearing. Clearing of the path between Treburyse business park to Tregadillett was a almost complete.

19/127 Current & ongoing business

- a. LCNP Climate Change Working Group. Ongoing.
- b. Community Governance Review. The recommendations put forward by South Petherwin Parish Council had been accepted. The next phase of the Cornwall Community Governance Review, draft recommendations to be published and a public consultation, will take place from 11th December 2019 until 24th March 2020.

19/128 New business

- a. Placement of a new Parish seat. A meeting with Cormac would be arranged in the new year to discussion a location.
- b. Speedwatch. The Speedwatch team are recruiting and would like to speak to the Parish Council at a Council meeting.
- c. Parish Safety event. Planning to commence in January 20120.
- d. VE celebration event 8th May 2020. The Parish Council Chairman would investigate prospective venues and contact subject matter experts.
- e. Water on the road at Daws House/Petherwin Water. Cormac had stated that they are aware of the severity of the issue and would clear the gutters and drains.
- **19/129 Cornwall Councillor's Report**. The present household waste contract has been extended for 6 months with a new contract to begin in the autumn, waste collection will be fortnightly and food waste collection will be weekly. The housing need list has reduced.
